Dear Secretary Becerra, Senator Wyden, and Representative Ocasio-Cortez:

We write to demand that you retract the dangerous, anti-democracy statements that each of you made in recent days. In response to a federal judge's thorough order ruling that, among other things, the FDA did not adequately consider the scientific evidence before approving an abortion drug, Senator Wyden and Representative Ocasio-Cortez encouraged the President to direct the FDA to defy the court's order, and Secretary Becerra admitted that the Biden administration is considering doing just that.¹

These statements are akin to a call to overthrow the Constitution. As Attorneys General, each of us signed briefs supporting this federal judge's ruling. In some other cases, however, we have been on the losing side, but we have nonetheless complied with the courts' orders. We have done so despite our disagreement with those orders because, under our Constitution, courts have final authority to settle concrete legal disputes between parties. Expressing mere *disagreement* with a court order, as all attorneys have done, is nothing like your call for the FDA not to *comply* with a court

order. The difference between the two is enormous. For a party to defy a court order simply because one does not like it is an attack on our very system of government and the rule of law.

You ought to know better. Like each of us, you have sworn an oath to uphold the Constitution. Your anti-Constitution rhetoric is more than just wrong. It also erodes the culture of the rule of law that has taken centuries to build. Other nations have fallen into tyranny quickly when those who should have been upholding the rule of law chose instead to lead mobs against it. Your rash, inflammatory, anti-Constitution statements are unacceptable. You must retract or resign.
