### THE STATE OF UTAH TO THE ABOVE-NAMED DEFENDANT:

The undersigned Scott Richardson, of the Utah Attorney General's Office, Utah Medicaid Fraud Control Unit, upon a written declaration states on information and belief that the Defendant, AMY LAURITZEN, committed the crime of:

### COUNT 1

### AGGRAVATED ABUSE OF A VULNERABLE ADULT, a Third Degree Felony, in

violation of Utah Code Ann. § 76-5-111.2(b)-(c) (2022, as amended), in Utah County, State of Utah,

from on or about January 26, 2022, thru on or about April 11, 2022, in that defendant, AMY LAURITZEN, a caretaker having the care or custody of a vulnerable adult, C.N. (initials used to preserve confidentiality), under circumstances likely to produce death or serious physical injury, recklessly caused or permitted C.N.'s person or health to be injured; or caused or permitted C.N. to be placed in a situation in which C.N.'s person or health was endangered.

Per Utah Code Ann. §76-5-111.2(3)(b), a violation of subsection (2) is a third degree felony if committed recklessly.

To wit: From on or about January 26, 2022, thru on or about April 11, 2022, Defendant, a registered nurse (Utah License #10394602-3102) who served as the Director of Nursing at Hidden Hollow Care Center ("DON"), an intermediate care facility located in Orem, Utah, served as a caretaker of C.N., a vulnerable adult with a diagnosis of schizophrenia.

On April 11, 2022, at approximately 0100 hours, C.N. was struck and killed by a vehicle in the parking lot of Hidden Hollow, where C.N. had been residing since approximately January 26, 2022. The driver of the vehicle was an employee of Hidden Hollow. The Orem Police Department investigated the accident and ruled it a suicide.

C.N. was known to have schizophrenia with suicidal ideation and prior suicide attempts. To treat C.N.'s schizophrenia, C.N.'s physician had prescribed a daily dose of 150 mg. of Clozapine, a prescription medication used to treat severely ill schizophrenic patients.

At the time C.N. moved into Hidden Hollow, C.N. did not have any Clozapine with him. Rather than scheduling appropriate medical evaluations so that C.N. could be officially admitted and receive proper medical treatment, Defendant, administered Clozapine to C.N. using a stash of discontinued medication saved from a prior patient(s). This borrowed medication was given to C.N. from approximately January 21, 2022, to April 1, 2022. Beginning April 1, 2022, the stash of Clozapine began to run out. From April 1-3, 2022, C.N. did not receive his full Clozapine dosage and from April 4, 2022, until April 11, 2022, the date of C.N.'s death, C.N. did not receive any Clozapine, in spite of the order for 150 mg. of Clozapine to be administered daily.

On April 7, 2022, Defendant documented in a treatment note that C.N. had been out of his schizophrenia medications for over a week. The following week C.N. exhibited uncontrolled behavior including hitting staff and residents, streaking outside, and laying down in the road and screaming that he wanted to die. Defendant denied witnessing any suicide attempts, but in the nursing assessment dated March 28, 2022, noted that, "C.N. has told me he wants to die but has not attempted anything as far as I am aware." Further, on April 5, 2022, C.N. hit staff member Jackie Cardwell on her leg. In comments on the incident report, Defendant wrote, "C.N. is currently out of his Clozapine and is struggling."

On April 7, 2022, C.N. streaked naked out of the facility and into the road. C.N. was overheard repeating that he needed to call 911 because he wanted to die. The corrective action noted in follow up to this event stated, "He was to call his brother and when [Defendant] arrived he was taken to see her for some meds." Again, on April 10, 2022, C.N. ran out of the facility, sat in the middle of the street and attempted to lay down. Hidden Hollow's Administrator (Administrator) pulled C.N. to his feet by pulling up on his armpits and escorted him back to the facility. The corrective actions said, "Administrator ran after him, assisted him to get up and walked back to the building." Nothing was reported in the "Plan of Future Corrective Actions" section.

In her role as DON, Defendant was a caretaker who had the duty to care for C.N., a vulnerable adult. Instead, she permitted C.N.'s health to be endangered by mismanaging medications, failing

to obtain necessary medical evaluations, and failing to properly follow up on suicidal behaviors. In doing so, Defendant has met the elements of Aggravated Abuse of a Vulnerable Adult.
